



- Built with **React and TypeScript** (same technology as Instagram, Facebook, etc.): Provides a fast, responsive and scalable interface that improves the user experience.
- Written using NestJS and Sequelize: Ensures agile, structured development capable
  of handling large amounts of data with ease.
- Infrastructure as code: We use **Docker and Kubernetes** (Google technology) to ensure automatic scalability and the ability to handle larger loads without interruption.
- We keep everything secure: With SSL encryption, restricted database access and JWT authentication, sensitive information is protected.
- Monitoring and backup: Tools such as Grafana and Redis ensure business continuity and rapid recovery from outages.
